**Personnel Update** – We're excited to announce our new yearly program for scouts! Officer Ben Vermaaten will be overseeing the new program "Super Saturday" that will take place Saturday, August 26th. Lt. Overly is currently working on the Franklin County Hazard Mitigation Plan 2023 update for the City of Bexley.

**Grant** – Lt. Overly is prepared to submit the State Homeland Security Program grant. Funding is being requested to support the CERT (Community Emergency Response Team) program, Community based workshops on preparing for a disaster, and a cargo van that will be utilized to transport needed equipment to disaster scenes and community training events.

**Alumni** – Fill-the-Cruiser event takes place on Friday, May 12 from 1000 a.m. - 2:00 p.m. in front of Montrose Elementary. The Alumni along with ACO Jennings will be collecting supplies for animal shelters.

**Detective Bureau** – A big congratulations goes out to the three officers who are being promoted to the rank of sergeant. Among those officers being promoted is Det. Fleming who has worked diligently in the detective bureau for the last year and a half. We look forward to watching each of them grow in their new roles.

Det. Byrd was assigned two new cases and closed one case. He was able to speak with two suspects over the phone out of ID frauds and has an in-person interview scheduled with one suspect. He also completed online training and spent a day with his Cyber Crime Task Force.

Det. Fleming closed four cases and submitted two cases to the prosecutor for felony indictments. He submitted evidence to the lab and assisted an elderly victim that was having issues with family and identity fraud.

Det. Briley closed four cases. He submitted evidence to BCI for investigations and submitted two cases to the prosecutor for presentation for felony charges. Det. Briley also conducted a juvenile well-being check.
