



Council Update – Chief of Police

Events –On June 2nd, Chief Lewis and Lt. Overly participated in the Bexley Pride Walk, and Lt. Overly served as a judge for Bexley's Got Talent.

The BCPAAA Shoe Drive is over. 750 pairs of shoes were collected and will be given a second life to those in need in under-developed countries.

On June 8th, the Bexley Police Department in conjunction with the National Organization of Black Law Enforcement Executives (NOBLE) and BeSmart conducted a gun lock giveaway event at the Bexley Pool.

Condolences – We are deeply saddened to announce that a very dear member of the BCPAAA, Harvey Solomon, passed away on Thursday, June 1st.

Detective Bureau – The past few weeks have been busy for the Bureau. Detectives assisted patrol officers in processing a robbery suspect and the vehicle used in the robbery. A subpoena was filed to obtain bank records that the suspect tried to access during the robbery. Evidence was collected and submitted to the lab in hopes to identify more suspects involved in the robbery.

Detectives were informed of a domestic violence incident where the victim was in the hospital. Detectives served multiple search warrants from this incident to gather evidence to present to the grand jury for a felony indictment.

The Bureau assisted with an audit of the property room and is working on new procedures to make the property room management more efficient.

Det. Byrd filed five subpoenas to different financial institutions to gather evidence for several forgery and ID fraud cases. Det. Byrd was able to identify two suspects out of two separate ID fraud and forgery cases. He will be filing warrants for their arrest in the coming weeks. He also filed an arrest warrant for a burglary suspect. Det. Byrd took a sexual assault report and worked with the Cyber Crime Task Force to finalize a case he is working on.

Det. Briley assisted in the processing of a crime scene from a felonious assault. He clerked several warrants and followed up on a stolen car report. He went to several businesses to collect security video from different cases he is working on. He interviewed two different victims, one from a car crash and one from an assault. He was also called in to process a stolen vehicle that

was recovered. Det. Briley submitted two cases to be presented to the Grand Jury and submitted items to BCI lab for analysis.
