



City Council Meeting Minutes

1) Call to Order

President Markham called the meeting to order at 6:06 pm.

10) Administrative Update

a) Police Department Update – Chief Gary D. Lewis, Jr.

Ms. Feibel spoke about the presence and support of our police officers during this difficult time for the Jewish community, and thanked Chief Lewis for her efforts. Mr. Kessler also reaffirmed the commitment he and the Chief have to the safety of our Jewish community and complimented the Chief on his efforts to consistently revisit and monitor this. Mr. Markham complimented the Coffee with a Cop event and thanked Chief Lewis for his continued commitment to true community policing, meeting residents and visitors regularly at events like this. Ms. Saad also complimented the success and reach of this event, and urged Chief Lewis to consider doing something similar in north Bexley at Bexley Coffee Shop. Chief Lewis thanked Council.

b) Service Department Update – Andy Bashore

Mr. Bashore added to his report that he believes the Drexel Avenue project will be completed in the next few weeks.

c) Recreation Department Update – Mike Price

Mr. Price covered some of the highlights of his report, specifically covering the pool membership report for the 2023 season and the positive feedback received on Swim Safe management. Mr. Klingler complimented the new pricing model for the pool which he feels is a huge win and the increase in memberships is a win. Ms. Saad gave a shout out to Natalie Mullin for her work. Ms. Lampke asked about feedback on the new concession stand vendor, which Mr. Price provided.

He also spoke about the success of Into the Woods and the success of the author talk and the upcoming Big Table event at the library. Mr. Klingler also commended the library, the Markhams, the City of Bexley, and Bryan Drewry on the Intel on Intel program.

12) Third Readings (No Speaker Slip Required)

- a) **Ordinance 30-23** to amend section 618.16 of the Bexley Codified Ordinances to authorize the Animal Control Officer to designate an animal as dangerous or vicious pending the review and adjudication by the Bexley Mayor's Court of any criminal charges filed pursuant to the codified ordinances, and to declare an emergency, introduced by Sam Marcellino on September 12, 2023.

Mr. Fishel read the ordinance and in Mr. Marcellino's absence Mr. Kessler reported Mr. Marcellino would like Council to vote on this ordinance but would like to request that Council table Ordinance 35-23.

Ms. Lampke spoke in favor of this ordinance and feels it is a good measure to increase the safety of residents. Ms. Saad spoke in favor of this ordinance.

Mr. Jim Hughes of 673 Montrose asked about the emergency declaration language and asked if this offers the Animal Control Officer the authority to declare an emergency. Mr. Markham invited Mr. Fishel to answer, which he did, explaining that this language permits the ordinance to go into effect immediately without the waiting period.

Mr. Markham moved to approve Ordinance 30-23.

- b) **Ordinance 32-23** to add Section 618.25 Animals in Unattended Motor Vehicles, in order to protect the health and welfare of animals in unattended vehicles, introduced by Sam Marcellino on September 12, 2023.

Mr. Fishel read this ordinance and Mr. Markham provided some background and his believe that Mr. Marcellino wanted this ordinance to go to vote as well.

Mr. Markham moved to approve Ordinance 32-23.

- c) **Ordinance 33-23** to amend Chapter 1456.01 Registration Required; and to add Chapter 1494, Mosquito Control Treatment, introduced by Lori Ann Feibel on September 12, 2023.

Mr. Fishel read the ordinance and Ms. Feibel stated that per the City Attorney, this ordinance needs to be withdrawn and invited Mr. Fishel to provide more information, which he did, explaining that this ordinance is in opposition to an existing state law.

Ms. Feibel moved to withdraw Ordinance 33-23.

- d) **Ordinance 35-23** to amend section 618.16(a)(5) of the Bexley Codified Ordinances to amend the definition of "Vicious Animal", and to reorder and amend existing Section 618.16(a)(8), introduced by Sam Marcellino on September 12, 2023.

Mr. Fishel read the ordinance and Mr. Markham reported Mr. Marcellino's request to table this ordinance.

Mr. Markham moved to table Ordinance 35-23.

Mr. Klingler seconded.

Ms. Lampke moved to adopt Resolution 6-23.

15) Tabled Ordinances

- a) **Ordinance 19-23** declaring the improvements to the former Trinity Seminary apartments site to be a public purpose; declaring such improvements to be exempt from real property taxation; requiring the owners thereof to make service payments in lieu of taxes; designating the public infrastructure improvements to be made that will directly benefit the real property; establishing a public improvement tax increment equivalent fund for the deposit of service payments; authorizing a revenue sharing agreement with the Bexley City School District; and authorizing a tax increment financing and redevelopment agreement with the developer of the site introduced by Matt Klingler on June 27, 2023.
- b) **Ordinance 27-23** to amend Chapter 452.06, "Unattended Vehicles: duty to lock ignition, remove key, set brake, etc." in order to modernize provisions of this section and to expand restrictions on idling for the protection of both the health of citizens and the environment, and to add Section 618.25, Animals in Unattended Motor Vehicles, in order to protect the health and welfare of animals in unattended vehicles; introduced by Lori Ann Feibel on August 15, 2023.

- All reasonable comments must be made within a maximum of three (3) minutes when addressing City Council.

- Defamatory or abusive remarks are always out of order.
- If the subject of the comment is not on the Council Agenda, the public may discuss the City issue during the Public Comments portion of the meeting. If the subject of the comment is on the Council Agenda, the public may discuss the issue at the time the issue is addressed during the Council meeting.
- Violation of this policy may result in termination of the speaker's comments and/or removal from the meeting.
- President of Council reserves the right to limit the length and scope of all Public Comments.
