



City Council Minutes  
**Tuesday, February 11, 2025**

**1. Call to Order**

Ms. Lampke called the meeting to order at 6:04 pm.

**2. Roll Call of Members**

Council Members in Attendance: Sam Marcellino, Lori Ann Feibel, Danny Hurley, Monique Lampke, Alex Silverman, Jess Saad

Ms. Lampke moved to excuse Mr. Markham's absence.

Mr. Marcellino seconded.

**3. Pledge of Allegiance**

**4. Special Guests:**

a.) Dr. Jason Fine (Superintendent, Bexley City Schools) and Kyle Smith (Treasurer, Bexley City Schools)

Dr. Fine thanked the City for allowing the schools to use Council chambers. Dr. Fine also spoke about the mission of the schools and spoke about the facility update process and steps to expect next. Dr. Fine then welcomed Mr. Smith to speak about the financial stewardship of the district.

Mr. Marcellino asked during which phase of the facilities update project the Board of Education will make decisions on who gets taxed and when, which Mr. Smith answered. He also asked about the Board of Education's temperature regarding the potential of including a school resource officer in the future and Dr. Fine shared that he would defer to the Board on this matter. Mr. Marcellino also asked about the potential impact of the recent federal orders regarding DEI on the school, which Dr. Fine answered. Mr. Silverman asked about how a potential withholding of federal funds would impact the schools and Mr. Smith provided some

information on this. Ms. Saad thanked them both for being there and encouraged Dr. Fine and the Board of Education to continue considering the issue of the School Resource Officer, sharing about the positive impact Officer Grimes has had at St. Charles.

**5. Ordinances with Visiting Presenters: John Theibert & Jay Sells of Aspen Energy**

- a) **Ordinance 05-25** to approve the supplier for the City of Bexley Electric Aggregation Program, introduced by Jess Saad on January 28, 2025. This is the Second Reading of this Ordinance.

Mr. Fishel read the ordinance and Ms. Saad and Mayor Kessler invited John Thiebert of Aspen Energy to share some updates on the Bexley Aggregation Program and the current energy market. Mr. Thiebert shared the attached slide presentation with Council regarding the existing aggregation program, the volatility of the electrical market and what Council's options are from here. Several Council members asked questions, which Mr. Thiebert and Mayor Kessler answered.

**6. Public Comments regarding items not on the Agenda (Speaker Slip Required)**

Ms. Lampke reminded everyone of the public speaking policy.

Mr. Constance Lewis of 663 Euclaire Ave urged Council to take care to use their microphones when speaking so that those who are listening virtually are able to hear.

**7. President's Report**

Ms. Lampke spoke about an upcoming documentary called 6888 being shown soon for Black History Month about a battalion comprised of Black women in World War II, and encouraged other to join her.

**8. City Attorney Report**

Mr. Fishel shared about a couple of pieces of state legislation that could have impact on Bexley, reminding everyone that these are not yet passed, but should be monitored. House Bill 26 would require local law enforcement to participate in federal immigration enforcement activity. He also shared about a bill being considered to modify the marijuana referendum, with the goal of redistributing the tax money that is currently designated to go to local municipalities with dispensaries. This bill also includes language to provide a sales tax exemption to a number of non-shotgun firearms.

**9. Auditor Report**

Mr. McPeek shared an update on investments and resulting interest income.

## **10. Administrative Update**

### **a) Mayor's Update**

Mayor Kessler shared his appreciation for Mr. McPeek and then covered some of the highlights from his report. He reminded everyone of the maple tree tapping event at Jeffrey Woods on Saturday and complimented Ms. Meyer on her recent speaking event at the Bexley Chamber breakfast. He also thanked Mr. Marcellino for continuing to pursue a solution for unusually high water bills, speaking about the water bill relief program he is working on rolling out this year.

### **b) Police Department, Gary D. Lewis**

Chief Lewis offered to answer any questions. Ms. Saad spoke about the teen driver program and complimented this idea, which Chief Lewis shared more detail on. Mr. Silverman asked if there was a cost, which he answered, sharing that the program is free. Mr. Marcellino asked if the Chief received any calls on drones, which Chief Lewis shared is infrequent.

### **c) Recreation Department, Mike Price**

Mr. Price shared some of the new changes planned for Jeffrey Woods Festival, which will now incorporate some Earth and Arbor Day events and activities. Mr. Hurley asked about the upcoming departure of Coach Chris, which Mr. Price spoke about, agreeing that he'll be very difficult to replace. Mr. Hurley asked if we could do anything to honor him, which Mr. Price confirmed is in the works.

### **d) Building Department, Matt Klingler**

Mr. Klingler doesn't have any thing to add to his written report, but Mayor Kessler shared that he's been impressed by the systems and efforts to tackle backlogs that Mr. Klingler has done. Mr. Marcellino asked about streamlining Code Violations and how that's going, which Mr. Klingler answered. Ms. Saad asked about the new landscape reviewer which is a replacement for Elena who is focused more on project design now.

- a) **Ordinance 01-25** to Approve the Collective Bargaining Agreement between AFSCME, Ohio Council 8, Local 3838 and the City of Bexley, introduced by Jess Saad on January 14, 2025.

Mr. Fishel read the ordinance and Ms. Saad provided some background on this ordinance.

Ms. Saad moved to adopt Ordinance 01-25.

Mr. Marcellino seconded.

Mr. Austin Fairbanks who lives on Allegheny Avenue encouraged Council to reject this AFSCME agreement, sharing a variety of concerns, including the opinion that merit-based factors should be included in contract language.

Ms. Lampke thanked Mr. Fairbanks for his comments and asked Mr. McPeck to call the vote.

- b) **Ordinance 02-25** to certify special assessments to certify special assessments for the various sites where the work was not done property owner after being ordered by the City in accordance with Bexley Code Section 1490.15(b)(4)A or Bexley Code Section 1492.04(b)(1) and it was necessary to do the work and assess the owner, introduced by Jess Saad on January 14, 2025.

Mr. Fishel read the ordinance and Ms. Saad shared that we need to check a few things and requested to table this ordinance. Prior to this. Ms. Lampke invited anyone who wanted to speak on this to approach.

Ms. Lewis of 663 Euclaire Avenue shared her support for this ordinance but expressed disappointment that a particular property was not included in this effort and asked what can be done on non-compliant properties. Mayor Kessler shared an update from a recent meeting about the property in question.

Mayor Kessler also urged Mr. Fairbanks to reach out to him directly with any questions.

Ms. Saad moved to table Ordinance 02-25.

- c) **Ordinance 04-25** to appropriate \$1,100,000 from the General Fund to effectuate the previously authorized transfer to the Capital Fund (\$500,000) and Water Fund (\$600,000); to appropriate \$8,500 from the General Fund to the Police Department account within the General Fund for Public Records Training and Management; and to appropriate and authorize the transfer of \$37,500 from the General Fund to the Water Fund for the Ohio EPA Lead Service Line Mapping Grant, introduced by Jess Saad on January 14, 2025.

Mr. Fishel read the ordinance and Ms. Saad provided some background and also shared the proposed amended ordinance attached.

Ms. Saad moved to amend Ordinance 04-25 as shown.

For the purpose of receiving comments from all speakers desiring to offer comments at City Council meetings, Council adopts the following policy:

- Speaker Slips are not required if you wish to comment on the Consent Agenda, at the Third Reading, or on a motion to adopt. Speaker Slips are required at all other times.
- If a Speaker Slip is Required, any speaker wishing to address Council shall complete a Speaker Slip and turn it in to the Clerk of Council or the City's Executive Assistant prior to the start of the meeting or during the designated agenda item requesting Speaker Slips be turned in. Such Speaker Slip must include the speaker's legal name, address, email address and phone number.
- All speakers must share their legal name/address when offering public comments.
- All public comments should be directed to City Council and should pertain to City of Bexley business only and where applicable, to the relevant Ordinance/Resolution.
- Comments must be made within a maximum of five (5) minutes (this limitation is the same rule that applies to City Council members per 220.01 (rule 13)).
- Please avoid offering points of view that have already been addressed by other speakers, if possible.
- Undue interruption or other interference with the order of business is not permitted.
- Comments that are abusive, disparaging, threatening, intimidating and/or are personal attacks are always out of order.
- Violation of this policy may result in termination of the speaker's comments and/or removal from the meeting.
- Council President reserves the right to limit the length/scope of Public Comments.
- You are also encouraged to email City Council Members([citycouncil@bexley.org](mailto:citycouncil@bexley.org)) if you'd prefer.
