

ORDINANCE NO. 148

DETERMINING TO PROCEED WITH THE IMPROVEMENT OF
COLUMBIA AVENUE FROM THE SOUTH LINE OF SOUTH COMMONWEALTH
AVENUE TO THE SOUTH LINE OF MARYLAND AVENUE

Be It Ordained by the Council of the Village of Bexley, State
of Ohio, to-wit:

SECTION 1. That it is hereby determined to proceed with the
improvement of Columbia Avenue from the south line of south Commonwealth
Avenue to the south line of Maryland Avenue in said village, by grading,
curbing, paving the roadway with brick, concrete or some form of asphalt
or some form of treated macadam, constructing sewers necessary to furnish
proper drainage for such improvement and constructing water and sewer
connections from the water main and sewers in said avenue to the inner
curb line thereof in accordance with the resolution declaring it neces-
sary to improve said avenue adopted by the Council of said Village on the
9th day of January, 1917, and in accordance with the plans, specifica-
tions, estimates and profiles of said proposed improvements, heretofore
approved and now on file in the office of the clerk of said village.

SECTION 2. That all claims for damages resulting therefrom
shall be judicially inquired into after the completion of the proposed
improvement, and the village solicitor be and he hereby is authorized and
directed to institute proceedings in a court of competent jurisdiction to
inquire into such claims.

SECTION 3. That the whole cost of said improvement together
with the interest on bonds issued in anticipation of the collection of the
assessments to be levied for said improvement, and all other necessary
expenditures less one-fiftieth (1/50) thereof, and the cost of inter-
sections shall be assessed by the foot front upon the following described
lots and lands, to-wit:

All lots and land fronting, bounding and abutting upon the
proposed improvement, which lots and lands are hereby determined to be
specially benefited by said improvement and in amount equal to the cost

thereof.

SECTION 4. That the sum of \$7,000.00 be and the same hereby is appropriated from the street improvement and intersection fund to pay the remainder of the cost of said improvement.

SECTION 5. That the assessments so levied shall be paid in ten (10) annual installments with interest on deferred payments at a rate not exceeding six per cent (6%) per annum: provided, that the owner of any property assessed may, at his option, pay such assessments or any number of the installments thereof at any time after said assessment has been levied with interest to the semi-annual interest day of said bonds next following date of payment.

SECTION 6. That bonds of the Village of Bexley, Ohio, shall be issued in anticipation of the collection of assessments by installments, and in an amount equal thereto.

SECTION 7. That the Clerk of said Village be and he hereby is authorized and directed to advertise for bids for the construction of said improvement according to law.

SECTION 8. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
