

AN ORDINANCE NO. 151

BY MR. N. C. Wolfe

To levy special assessments for the improvement of Columbia Avenue from the south line of South Commonwealth Avenue to the south line of Maryland Avenue, by grading, curbing, paving the roadway, constructing sewers necessary to furnish proper drainage for such improvement, and constructing water and sewer connections.

Be it ordained by the Council of the village of Bexley,
State of Ohio:

Section 1. That to pay the portion of the cost and expenses heretofore determined to be specially assessed for the improvement of Columbia Avenue from the south line of South Commonwealth Avenue to the south line of Maryland Avenue in said village by grading, curbing, paving the roadway, constructing sewers necessary to furnish proper drainage for said improvement and constructing water and sanitary sewer connections, from the water main and sanitary sewer in said avenue to the inner line of the curbs, therefore and hereby is levied and assessed upon the lots and lands fronting and abutting upon said improvement hereinafter described, the several amounts hereinafter set forth, to-wit:

Which Assessments are \$5.8338 per front foot of the property assessed.

Section 2. That the total assessment against each lot shall be payable in cash to the village treasurer within thirty days and from the final passage of the ordinance, or, at the option of the owner, in ten annual installments, with interest at the rate of five per (5%) per annum payable semi-annually upon the deferred payments, at the office of the county treasurer of Franklin County, Ohio, after the same has been certified to the County Auditor for collection in the manner provided by law. Said assessments after being so certified may however, be paid in full, or any number of annual installments may be paid, at any tax collection time, with interest on the same to the semi-annual interest day next ensuing. If said installments of assessments are not paid as and when the same become due, a penalty will be imposed and collected as provided by law.

Section 3. That said assessments when collected shall be applied to the payment of the bonds issued for said improvement and the interest thereon, as the same shall become due and to no other purpose what soever.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
