Ordinance No. 185

TO VACATE ASHBOURNE ROAD  
AND ASHBOURNE PLACE, THE  
SAME BEING STREETS IN THE  
VILLAGE OF BEXLEY, THROUGH-  
OUT THEIR ENTIRE RESPECTIVE  
LENGTHS.

Whereas, on the 26th day of February, 1918, a petition by persons owning lots in the immediate vicinity of Ashbourne Road and Ashbourne Place throughout their entire respective lengths, was duly presented to Council praying that said streets, throughout their respective lengths, be vacated; and notice of the pendency and prayer of said petition has been given as required by law, by publication in The Ohio State Journal, a newspaper of general circulation in the corporation, for six consecutive weeks, ending on the 4th day of April, 1918; and

Whereas, Council upon hearing, is satisfied that there is good cause for such vacation of said Ashbourne Road and Ashbourne Place as prayed for, that it will not be detrimental to the general interest and ought to be made;

Now therefore, be it ordained by the Council of the Village of Bexley, State of Ohio:

SEC. 1. That Ashbourne Road and Ashbourne Place, both being streets in the Village of Bexley, be, and the same are, hereby vacated throughout their entire respective lengths.

SEC. 2. That this ordinance be and remain in force from and after the earliest period allowed by law.

AN ORDINANCE NO. 185-

BY MR. Dunlap

To levy special assessments for the improvement of Ashbourne Road in the village of Bexley, Ohio, and to repeal ordinance No. 171, passed October 2nd, 1917.

Be it ordained by the Council of the Village of Bexley, State of Ohio:

SECTION 1. That to pay that portion of the cost and expenses hereto determined to be specially assessed for the improvement of Ashbourne Road in said village by grading, curbing and paving the roadway, constructing sewers necessary to furnish proper drainage for such improvement, and constructing water and sanitary sewer connections from the water main and sanitary sewer in said Avenue to the lots and lands fronting and abutting thereon, there be levied and assessed upon the lots and lands hereinafter described, the several amounts hereinafter set forth, to-wit:

which assessments are at the rate of \$8.87686 per front foot of the property assessed.

SECTION 2. That the total assessments shall be payable at the office of the treasurer of the village of Bexley, Ohio, within the period of thirty days from the date of the final passage of this ordinance, or at the option of the owner, in twenty annual installments with interest at the rate of five (5%) per cent. per annum upon deferred payments, at the office of the treasurer of Franklin County Ohio, after the same has been certified to the county auditor for collection in the manner provided by law. If said installments of said assessments are not paid when the same become due, a penalty will be imposed and collected, as provided by law.

SECTION 3. That said assessments and all portions thereof when collected shall be paid into the sinking fund and shall be applied to the payment of the bonds issued for said improvement and the interest thereon as the same shall become due, and to no other purpose whatsoever.

SECTION 4. That ordinance No. 171, passed October 2nd, 1917, entitled an ordinance "To levy special assessments for the improvement of Ashbourne Road in the village of Bexley," be and the same hereby is repealed.

SECTION 5. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
