

AN ORDINANCE NO. 697.

Determining to proceed with the improvement of certain streets and avenues in the Village of Bexley, by constructing water lines therein.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That it is hereby determined to proceed with the improvement of the following streets and avenues in the Village of Bexley, by constructing water lines as follows, to-wit:

Cassady Road from Maryland Avenue to Caroline Avenue, by constructing a twelve (12) inch water main therein.

Maryland Avenue (in Bellwood Addition) from Cassady Road to Hemlock Street, by constructing a six (6) inch water main therein.

Allegheny Avenue from Cassady Road to Hemlock Street, by constructing a six (6) inch water main therein.

Columbus Avenue from Cassady Road to the east line of Bellwood Addition, by constructing a six (6) inch water main therein.

Stanwood Road from Maryland Avenue to the north line of Beacon Hill Addition, by constructing a six (6) inch water main therein.

Hemlock Street from the north line of Beacon Hill Addition to Maryland Avenue in Bellwood Addition, by constructing a six (6) inch tie line therein, connecting the above mentioned mains, said lines hereinabove provided being one improvement; also constructing the necessary fire hydrants; in accordance with the plans, specifications and estimates prepared by the Engineers of the Village and now on file in the office of the Village Clerk, which plans, specifications and estimates have heretofore been approved.

Section 2. That all claims for damages resulting from said improvement shall be judicially inquired into after the completion of the improvement and the solicitor hereby is authorized and directed to institute proceedings in a court of Competent Jurisdiction to inquire into such claims.

Section 3. That the whole cost of said improvement, less fourteen per cent (14%) thereof shall be specially assessed in proportion to the benefits which may result from said improvement upon the following described lots and lands, to-wit:

All of the lots and lands bounding, fronting and abutting upon said proposed improvement between the points aforesaid, which said lots and lands hereby are determined to be specially benefited by said improvement and in an amount equal to that part of the cost thereof hereby determined to be assessed thereon.

Section 4. That the special assessments so to be levied shall be paid in five (5) equal annual installments, with interest on the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the collection of such assessments.

Section 5. That said Village may borrow money and issue notes due and payable not later than two years from the date of issue, in anticipation of the levy of said special assessments and of the issuance of bonds in anticipation of the collection thereof as provided in Section 3914 of the General Code of Ohio. Said notes shall not exceed in amount that portion of the estimated cost of the improvement for which said special assessments are to be levied.

Section 6. That bonds of said village shall be issued in anticipation of the collection of said assessments, in an amount sufficient to pay that portion of the estimated cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

Section 7. That the Village's portion of the cost of said improvement shall be paid from the proceeds of bonds issued by said Village in the manner provided by law.

Section 8. That the Clerk be and hereby is authorized and directed to advertise for bids for the construction of said improvement according to law.

Section 9. This ordinance shall take effect and be in force from and after the earliest period allowed by law.




