

## ORDINANCE NO. 1081.

By Mr. Manly.

To establish the grade of curbs on Park Drive from Park Hill Drive to Fair Avenue, in the Village of Bexley, Ohio.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the permanent grade of the curbs on Park Drive from Park Hill Drive to Fair Avenue, be and the same are hereby established as follows, to-wit:-

EAST CURB:

Beginning at station 0+00 and elevation 73.40 the end of the curb of Park Hill Drive; thence northerly on a vertical curve with the following stations and elevations:

Station 0+20	Elevation 72.10
" 0+40	" 71.35
" 0+60	" 71.00
" 0+80	" 70.80
" 1+00	" 70.85

thence northerly on a 0.30% ascending grade to Station 3+00 and elevation 71.45; thence northerly on a vertical curve with the following stations and elevations:

Station 3+25	Elevation 71.61
" 3+50	" 71.94
" 3+75	" 72.43
" 4+00	" 73.10

thence northerly on a 3.00% ascending grade to station 4+65 and elevation 75.05; thence northerly on a vertical curve with the following stations and elevations:

Station 4+90	Elevation 75.70
" 5+15	" 75.92

thence on a 0.30% ascending grade to the center line of Fair Avenue at station 5+41.8 and elevation 76.00.

WEST CURB:

Beginning at station 0+00 and elevation 71.14 the end of the curb of Park Hill Drive; thence northerly on a vertical curve with the following stations and elevations:

Station 0+20	Elevation 72.80
" 0+40	" 72.03
" 0+60	" 71.60
" 0+80	" 71.25
" 1+00	" 71.09

thence northerly on a 0.30% descending grade to station 1+40 and elevation 70.97; thence on a 0.30% ascending grade to station 3+00 and elevation 71.45; thence northerly on a vertical curve with the following stations and elevations:

Station 3+25	Elevation 71.61
" 3+50	" 71.94
" 3+75	" 72.43
" 4+00	" 73.10

thence northerly on a 3.00% ascending grade to station 4+65 and elevation 75.05; thence northerly on a vertical curve with the following stations and elevations:

Station 4+90	Elevation 75.70
" 5+15	" 75.92

thence on a 0.30% ascending grade to the center line of Fair Avenue at station 5+41.8 and elevation 76.00.

The above stations are on the center line of the street.

The above elevations refer to Village Datum.

Section 2. This ordinance shall take effect and be  
in force from and after the earliest period allowed by law.
