

RESOLUTION NO. 25-32

Adopting plans;
Proposing to cooperate;
Requesting Director to proceed;

By Mr. Pretzman,

Whereas, At a meeting of the City Council of the City of Bexley, Franklin County, Ohio, held in the office of the Council of said City, on the 29th day of August, 1932, a quorum being present, the improvement of the Columbus-Newark Road, State Highway No. 47, under the provisions of Section 1178 and related sections inclusive of the General Code of Ohio, came on for further consideration; said portion of road as described in the preliminary application of this Council to the Director of Highways, on the 12th day of January, 1932, being as follows:

"Beginning at the east end of the bridge over Alum Creek, and running thence east to the east corporation line of said city, and being that portion of said highway lying within the corporate limits of said City of Bexley, in all a distance of about one mile".

Whereas, the Council of the City of Bexley, Franklin County, Ohio, in said preliminary application, proposes to cooperate in the construction of the above described portion of State Highway No. 47, by assuming and contributing the entire cost, except the construction cost of a twenty-foot roadway, including the grading and necessary drainage, inclusive of engineering, preliminary contingencies and other incidental expenses.

Whereas, The Director of Highways has approved said application and has caused a map of the following described section of said highway to be made in outline and profile:

Beginning at the east end of the bridge over Alum Creek, and running thence east to the east corporation line of said City, and being that portion of said highway lying within the corporate limits of said City of Bexley, in all a distance of 1.417 miles.

Whereas, The Director of Highways has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway, and has transmitted the same to this council with the certificate of his approval indorsed thereon:

Whereas, Funds for the payment of the estimated cost of said improvement other than the proportion and share of said cost that is to be borne by the State of Ohio and the City of Columbus, Ohio, have become available, as to which funds the City Auditor has made a certificate, now on file with this Council and here recorded as follows:

I hereby certify that the money, to-wit: \$101,300.00 required for the payment of the cost other than that part thereof assumed by the State, of the improvement known as State Highway No. 47, Sections "Bexley" and "Columbus", County of Franklin, City of Bexley, is in the treasury to the credit of, or has been levied, placed on the duplicate and in process of collection for the state and City road improvement fund and not appropriated for any other purpose; or is being obtained by sale of bonds of said City issued on account of said improvement, which bonds are sold and in process of delivery.

I further certify that this certificate was made, sealed and filed with the City Council of the City of Bexley, Franklin County before said City Council passed the final resolution in connection with the within described project; and that this certificate was forthwith recorded in the record of proceedings of said City Council namely: Council's Journal, Volume , at page .

Whereas, This Council desires the Director of Highways to proceed with the aforesaid work; Therefore Be it

RESOLVED, That the section of highway above described be improved under the provisions of aforesaid law. That said work be done under the charge, care and superintendence of the Director of Highways and that said maps, plans, specifications and estimates for this improvement as approved by the Director of Highways, are hereby approved and adopted by this Council.

RESOLVED, That this Council is still of the opinion the proposed work on the above described section should be constructed; and that the City should cooperate upon the basis set forth in their proposal:

RESOLVED, That the sum of ONE HUNDRED ONE THOUSAND THREE HUNDRED AND NO/100 Dollars (\$101,300.00), being \$200,620.00 less than the total cost and expense of the construction of said improvement which total estimated cost and expense is THREE HUNDRED ONE THOUSAND SIX HUNDRED TWENTY AND NO/100 Dollars (\$301,620.00), be and the same is hereby appropriated for improving under the provisions of said law, the highway described above; and the City Auditor is hereby authorized and directed to issue his order on the City Treasurer for said sum or part thereof upon the requisition of the Director of Highways, to pay the cost and expense of said improvement, as the same may become due under provisions of said law. We hereby agree to assume in the first instance the share of the cost and expense over and above the amount to be paid by the State of Ohio and the City of Columbus, Ohio, and guarantee the Director of Highways that such money shall be available at such time or times as it may be needed in the construction of said highway.

RESOLVED, That this Council hereby requests the Director of Highways to proceed with the aforesaid proposed work.

RESOLVED, That this City Council of the City of Bexley, Franklin County, Ohio, enter into a contract with the Director of Highways of the State of Ohio providing for the payment by said

City Council of the City of Bexley, Franklin County, Ohio, the sum of ONE HUNDRED ONE THOUSAND THREE HUNDRED AND NO/100 Dollars, (\$101,300.00), the agreed proportion of the cost and expense to be borne by the City of Bexley, Ohio, for improving Sections "Bexley" and "Columbus" of the Columbus-Newark Road, State Highway No. 47 in the City of Bexley, Franklin County, Ohio.

BE IT FURTHER RESOLVED, That the clerk of this Council, be, and he is hereby directed to transmit to the Director of Highways a certified copy of these resolutions.

That this resolution shall take effect and be in force from and after the earliest period allowed by law.
