

ORDINANCE NO. 50-32.

By Mr. Klingbeil.

Providing for the repair of certain streets in the
City of Bexley.

Whereas, by Ordinance No. 53-31, duly passed June 30, 1931, settlement was made with the estate of A. G. Pugh, contractor, of certain Sinking Fund certificates held by said estate under various contracts as a guaranty for the maintenance of said streets during the five year maintenance period whereby said City retained certain amounts, as hereinafter set forth, for the repair of said respective streets and paid the balance of the funds represented by said certificates to said estate and agreed to make the necessary repairs to said streets and relieve the estate of said A. G. Pugh from the same, said streets and the estimated repairs and amounts retained being as follows, to-wit:-

Whereas, council is of the opinion that said respective streets, above listed, should now be repaired by patching the surface where necessary, filling cracks therein with tar or asphalt, replacing defective curbing and base, and making other necessary miscellaneous minor repairs, the same to be paid out of said retained funds hereinabove listed, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the Mayor be and he hereby is authorized and empowered to cause said above named streets severally to be placed in repair by patching the surfaces thereof, filling

cracks therein with asphalt or tar, replacing defective curbing and base, and making the necessary miscellaneous minor repairs thereon, all in the manner provided in the several contracts of said contractor for the improvement of said streets, which contracts in effect provide that if said contractor should fail to make said repairs during the five year maintenance periods therein provided, then the City was thereby authorized to make said repairs or cause the same to be made and pay for the cost thereof out of said retained monies, and that the cost thereof be paid out of the funds so retained under said agreement with the estate of said A. G. Pugh, and that, whereas, said several funds have heretofore been placed in the general fund, the total amount of said estimated repairs of said several streets, amounting to \$2731.67, is hereby appropriated from said general fund for that purpose.


Section 2. This ordinance is an emergency ordinance and necessary for the immediate preservation of the public peace and safety, said emergency being that said repairs should be made before the coming of cold and inclement weather, for which reason this ordinance shall go into immediate force and effect.
