

RESOLUTION NO. 15-42 ✓

Amending Section 3 of Resolution No. 14-42, declaring it necessary to improve Powell Avenue from Parkview Avenue to Drexel Avenue, by grading and paving the roadway thereof with concrete, constructing concrete curbs and gutters, and necessary drains to provide drainage for said improvement, constructing sidewalks on both sides thereof, and driveway entrances from curb to sidewalk, and declaring an emergency.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEALEY, STATE OF OHIO:

Section 1. That Section 3 of Resolution No. 14-42, adopted on the 8th day of September, 1942, declaring it necessary to improve Powell Avenue from Parkview Avenue to Drexel Avenue, by grading and paving the roadway thereof with concrete, constructing concrete curbs and gutters, and necessary drains to provide drainage for said improvement, constructing sidewalks on both sides thereof, and driveway entrances from curb to sidewalk, be and hereby is amended to read as follows:

Section 3. That the entire cost of said improvement less 60% and the cost of intersections shall be assessed in proportion to the benefits which may result from the improvement upon the following described lots and lands, to-wit: all lots and lands bounding and abutting upon said proposed improvement, which said lots and lands are hereby determined to be specially benefitted by said improvement, in an amount not less than the cost thereof, and the cost of said improvement shall include the expense of the preliminary and other surveys, and of the printing and publishing of notices, resolutions and ordinances required, the serving of said notices, the cost of construction, together with interest on notes and bonds issued in anticipation of the collection of deferred assessments, and of all other necessary expenditures.

Section 2. This resolution is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, said emergency being that said street is in a condition dangerous to public traffic and should be immediately improved, and said resolution shall go into immediate force and effect.
