

ORDINANCE NO. 19-47

To amend Section 28 of Ordinance No. 47-36, to establish a traffic code for the City of Bexley, Ohio, passed November 24, 1936.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That Section 28 of Ordinance No. 47-36, to establish a traffic code for the City of Bexley, Ohio, passed November 24, 1936, be and the same is hereby amended to read as follows:

"Section 28. PARKING. a. No vehicle shall stop in any street in the City, except in such position that all parts of the vehicle shall be within seven feet of the curb, nor in such a way as to obstruct the free passage of the street; provided, however, that nothing in this section shall be held to prohibit steps compelled by other regulations herein, nor to prohibit trucks or vans from loading or unloading.

b. Except in case of accident, or other emergency, or when directed to stop by police, no vehicle shall stop in such a way as to obstruct any street or crossing, and then shall move on again as soon as possible.

c. No vehicle shall be permitted to park or stand within a space of twenty feet in length along the curb line in front of or near the main entrance to any church, theatre, hotel, bank, mortuary, hospital, or state, county or municipal building; said space to be designated by the Mayor, and caused to be marked or indicated by markings on the sidewalk or curb, or by standards or signs, during the time in which such building is used or occupied, except for the purpose of stopping to take on, or let off passengers, or for loading or unloading merchandise, and then only for a sufficient length of time to accomplish such purpose; nor shall any vehicle be permitted to park or stand in front of the entrance to a public driveway, or before a private driveway or garage entrance, except with the consent of the owner thereof. Signs or standards used as markers in front of any private building, as provided in this section, shall only be erected upon direction of the Mayor, and shall be erected at the expense of the property owner, or tenant.

d. No part of any vehicle shall be parked on any sidewalk of any street or alley.

e. No motor truck shall be parked or left standing on any street or alley in the City of Bexley, longer than six hours, between the hours of ten o'clock P. M., and six o'clock A. M., of the following day. No vehicle shall be parked or left standing on any street or alley in such a manner as to interfere with the free ingress and egress to any garage.

f. In addition to the above parking provisions the following non-parking areas are hereby created:

1. Caroline Avenue from North Cassady Road to North-view Drive; north side thereof.

2. South Cassady Road from East Main Street to the first alley north thereof; east side thereof.
3. North Cassady Road from Columbus Avenue north to Allegheny Avenue; east side thereof.
4. South Cassingham Road, between Main Street and Mound Street; east side thereof.
5. South Cassingham Road from East Main Street north to the first alley north thereof; east side thereof.
6. South Cassingham Road, from East Broad Street to a point 780 feet south thereof; east side thereof.
7. College Avenue from East Main Street south to East Mound Street; west side thereof.
8. Dawson Avenue from East Main Street to the first alley north thereof; east side thereof.
9. South Drexel Avenue from the north curb line of East Main Street to a point 56 feet and 6 inches north thereof; west side thereof.
10. South Drexel Avenue from the north curb line of East Main Street to a point 56 feet and 6 inches north thereof; east side thereof.
11. Euclaire Avenue from East Main Street, to the first alley south thereof; east side thereof.
12. Main Street, from the east curb line of South Drexel Avenue to a point 32 feet and 6 inches east thereof; north side thereof.
13. Main Street, from the west curb line of South Drexel Avenue to a point 58 feet and 6 inches west thereof; north side thereof.
14. Main Street, from College Avenue to Drexel Avenue, south side thereof, between the hours from 4:00 P. M. until 9:00 P. M.
15. Montrose Avenue from East Main Street, south to the Mound Street; east side thereof.
16. Pleasant Ridge Avenue from East Main Street to the first alley south thereof; west side thereof.
17. Remington Road between Fair Avenue and Main Street.
18. Remington Road from East Main Street south to East Mound Street; west side thereof.
19. Sheridan Avenue, between Main Street and Mound Street; east side thereof.

Section 2. Original Section 28 of said Ordinance No. 47-36, and any amendments thereto, are hereby repealed.

Section 3. This ordinance shall take effect and be in force from and after the earliest period provided by law.
