

RESOLUTION NO. 3-48

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

That sidewalks shall be constructed on both sides of the following streets, and highways in the City of Bexley, between the following points, to-wit:

Boston Avenue, from Columbia Avenue to Drexel Avenue
Bryden Road, from Parkview Avenue to Drexel Avenue
Cassady Road, from Ruhl Avenue to Caroline Avenue
Commonwealth Park North, from Parkview Avenue to Drexel Avenue
Commonwealth Park South, from Parkview Avenue to Columbia Avenue
Denver Avenue, from Drexel Avenue to Ashbourne Road
Mound Street, from Sheridan Avenue to College Avenue
Roosevelt Avenue, from Main Street to Broad Street
Park Drive & Parkhill Drive, from Westland Avenue to Fair Avenue

Said sidewalks shall be constructed of concrete and shall be of the uniform width of four feet, unless a different width shall be ordered by the Mayor in order to conform to existing sidewalks. Said sidewalks shall be constructed in accordance with the plans and specifications for sidewalks heretofore adopted by Council and now on file in the office of the Mayor; they shall be constructed with a cross-slope of $\frac{3}{8}$ ths of an inch per foot, and shall be placed with the inside edge, being the edge next to the lot line, two feet from the lot line, and at an elevation above the curb grade of $\frac{3}{8}$ ths of an inch for each foot that the sidewalk is distant from the curb, plus one inch rise at the curb; provided, however, the Mayor may, by special order, direct a different location with reference to lot lines, or a different slope or elevation for any sidewalk to conform with grades and locations of existing sidewalks.

The foot of the terrace slope of any lot shall not extend into the street beyond the property line.

That the clerk of Council shall, and he is hereby directed to, cause a written notice of the passage of this resolution to be served as required by law.
