

RESOLUTION NO. 1 -58

By Mr. Sardul

To provide for the repairing of sidewalks at the locations hereinafter provided.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

That the sidewalks in front of the premises hereinafter set forth be repaired in the following manner: According to the specifications heretofore adopted by Council, now on file in the office of the Mayor, and in accordance with the provisions of the general ordinance, being Ordinance No. 11-48, providing for the construction, reconstruction and repair of sidewalks, and providing that the same shall be constructed with a cross-slope of $\frac{3}{8}$ ths of an inch per foot, and shall be placed with the inside edge, being the edge next to the lot line, two feet from the lot line, and at an elevation above the curb grade of $\frac{3}{8}$ ths inch for each foot that the sidewalk is distant from the curb, plus one inch rise at the curb; provided, however, in order to conform to existing sidewalks or to meet special conditions, the Mayor by special order, may direct a different location with reference to lot lines, or a different elevation for any sidewalk, which special order shall prevail.

Said premises in front of which said sidewalks shall be repaired, and the owners thereof, being as follows:
