

RESOLUTION NO. 9 -76

Authorizing the Mayor to execute a cooperation agreement with the Board of Commissioners of Franklin County, Ohio, pursuant to the Housing and Community Development Act of 1974 (Public Law 93-383, 42, U.S.C. 5301).

Whereas, the Board of Commissioners of Franklin County and the City of Bexley, Ohio, desire to undertake jointly planning and administrative activities essential to the preparation of an application for urban county entitlement funds and implementation of programs pursuant to the Housing and Community Development Act of 1974 (P.L. 93-383, 42 U.S.C. 5301); and

Whereas, the Housing and Community Development Act of 1974 (hereafter referred to as the Act) provides for entitlement grants to urban counties; and

Whereas, the City of Bexley, Ohio, is within the geographical boundaries of Franklin County and desires to participate in the Community Development Program in the third program year, as provided in Section 570.105 b 3(111) of the Community Development Block Grant Rules and Regulations.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY:

Section 1. That the City of Bexley does hereby enter into a cooperation agreement with the Board of Commissioners of Franklin County, Ohio, to undertake planning and administrative activities, preparation of applications for urban county entitlement funds and implementation of programs under the Act.

Section 2. That the Mayor is hereby authorized and directed to execute a cooperation agreement with the Board of Commissioners of Franklin County, Ohio.
