

ORDINANCE NO. 22 -85

An Ordinance to authorize the Mayor and the Auditor to execute a contract with the District Advisory Council of the Franklin County General Health District and to appropriate necessary funds.

WHEREAS, the Bexley Board of Health receives a subsidy from the State of Ohio to support its activities; and

WHEREAS, the Ohio Department of Health has promulgated minimum standards to be maintained by local health departments in order to be eligible to receive a state subsidy; and

WHEREAS, the Bexley Board of Health does not have adequate staff to perform all of the services required by the State of Ohio; and

WHEREAS, the District Advisory Council of the Franklin County General Health District is willing to provide certain services to supplement those provided by the Bexley Board of Health in order that the Bexley Board of Health will meet minimum standards of the Ohio Department of Health; now, therefore;

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and the Auditor are hereby authorized to execute a contract for supplemental public health services with the District Advisory Council of the Franklin County General Health District in form and substance acceptable to the City Solicitor.

Section 2. That the sum of \$4,000 should be, and it hereby is, appropriated and set aside from the unencumbered General Fund to be used to pay fees for consulting services provided pursuant to said contract.

Section 3. That this Ordinance is an emergency Ordinance necessary for the immediate preservation of the public peace, health and safety; and, therefore, such Ordinance shall go into effect upon its passage and its approval by the Mayor.

C O N T R A C T

BETWEEN THE CITY OF BEXLEY, OHIO, AND THE DISTRICT ADVISORY COUNCIL OF
THE FRANKLIN COUNTY GENERAL HEALTH DISTRICT.

W I T N E S S E T H

SECTION 1. The District Advisory Council of the Franklin County General Health District shall for the consideration hereinafter stated furnish to the City of Bexley, Ohio, and the inhabitants thereof, all such partial public health services for the purpose of meeting minimum public health standards as are furnished by said Council to all villages, townships and the inhabitants thereof, of Franklin County, Ohio. Said partial services as are furnished shall include the following:*

- 3701-36-05 Health Education
- 3701-36-06 Communicable Disease Control
- 3701-06-07 Chronic Disease Control
- 3701-06-08 Genetic Disease Control
- 3701-06-09 Primary Care
- 3701-06-10 Laboratory Services
- 3701-06-14 Vector Control
- 3701-06-17 Child Health
- 3701-06-18 Nutrition Services
- 3701-06-20 Family Planning
- 3701-06-21 Substance Abuse
- 3701-06-22 Disaster Preparedness
- 3701-06-23 Accident Prevention

SECTION 2. Whenever any additional service or any new program is planned, approval of the City Council must be secured unless an actual emergency endangering the public health exists. Any program offered as an optional activity must be approved by the City Council. In cases where court action may be necessary in order to secure the public health, the Mayor of the City shall be informed of the legal action proposed by the representatives of the Health Department and he shall agree thereto.

SECTION 3. Said partial public health services shall be rendered for one (1) year from May 23, 1985 and ending May 22, 1986, provided, however, that either party to this agreement may cancel the same upon four (4) month written notice, and payment shall be prorated to date on cancellation.

SECTION 4. The Health Department shall render a report every ninety (90) days to the Health Commissioner of the City of Bexley on all services directly rendered to the Bexley citizens. Such report shall describe the type of service, where the service was rendered, and the number of cases, visits or other appropriate work units.


SECTION 5. The City of Bexley, Ohio, shall pay to the Franklin County General Health District for said partial Public Health Services furnished to the City of Bexley, Ohio, and the inhabitants thereof, such sum in the amount of four-thousand (\$4,000.00) dollars.

SECTION 6. Such sum of money shall be paid by the City of Bexley, Ohio, to the District Advisory Council of the Franklin County General Health District. Said sum of money shall be paid by the City of Bexley, Ohio, within thirty (30) days after receipt of invoice.



DEFINITIONS OF PARTIAL PUBLIC HEALTH STANDARDS

3701-36-05 HEALTH EDUCATION

The Franklin County Board of Health proposes an annual hypertension screening program for residents of Bexley to be held at sites convenient to residents. Health education, health counseling and referral (based upon American Heart Association criteria) will be an integral part of the screening. The education component will include a statement of educational objectives, specification of target groups and educational methods to be employed. An evaluation of the program will be made and will be available to the Bexley Board of Health. A program review and an annual evaluation report will be conducted. Future health programs will be based upon the annual evaluation.

3701-36-06 COMMUNICABLE DISEASE CONTROL

The Franklin County Board of Health has an existing plan for the analysis and prevention of communicable disease within Franklin County. Health providers and schools telephone or send information concerning reportable communicable diseases to the Franklin County Board of Health. Home visits are made by public health nurses for the purposes of instruction concerning appropriate and adequate treatment, isolation and disinfection where appropriate, and identification and follow up of all contacts. The public health nurse also assists the individual or family in obtaining medical care if this is needed. Major communicable disease problems are analyzed and appropriate plans of treatment are developed. An annual evaluation of the communicable disease program is conducted.

Immunization clinics are held throughout the county and are open to Bexley residents. An immunization clinic may be offered within the Bexley area if the need is justified for a separate clinic.

The Franklin County Board of Health promotes prompt reporting of all animal bites, investigates all animal bites and issues quarantine and vaccination orders. Rabies vaccine and Rabies Immune Globulin is provided at no charge to Franklin County residents by the Franklin County Commissioners.

A plan exists for the rapid and effective response to communicable disease outbreaks. Review and evaluation of the plan is conducted annually. Health education programs are planned for communities based upon the annual evaluation.

3701-36-07 CHRONIC DISEASE CONTROL

The Franklin County Board of Health obtains data regarding the incidence and prevalence rates and the treatment of chronic diseases from local, state and federal sources. A telephone survey of risk factors associated with the development of chronic diseases was conducted in August, 1984. This survey, along with subsequent surveys, will assist in developing appropriate health education programs for communities. High risk populations will be linked with appropriate community resources for the treatment of chronic disease. A computerized health risk appraisal program also is available for individuals to utilize.

The health risk appraisals are analyzed by the Ohio Department of Health and returned to the participating individuals. These appraisals are valuable tools in promoting positive health behavior with individuals or groups.

3701-36-08 GENETIC DISEASE CONTROL

The Franklin County Board of Health participates in newborn genetic, endocrine and metabolic screening programs for phenylketonuria, hypothyroidism, homocystinuria and galactosemia. Information is provided to prenatais and to the parents of newborn infants regarding available diagnostic services. Information concerning genetic diseases is disseminated to the public through group meetings, school health personnel and other maternal and child health programs.

3701-36-09 PRIMARY CARE

The Franklin County Board of Health monitors the availability of primary care and assesses the availability and accessibility of adequate primary care in Franklin County by participating with other health organizations and providers. Physical examinations are provided to all citizens and school children who are seeking employment. Referrals to affordable health care facilities are provided for the medically indigent.

Twenty-four hour/7-day-a-week home care services (registered nurses, home health aides, physical therapy, speech therapy, occupational therapy, enterostomal therapy and respiratory therapy) are available to residents of Franklin County. Payment sources are from Medicare, Medicaid, Private Insurance, Private Pay, and Title XX.

The Franklin County Board of Health also offers a mobile health van for the provision of health services to individuals 60 years and over.

3701-36-14 VECTOR CONTROL

To aide Bexley's Mosquito Control Program, this department will furnish necessary equipment, materials and manpower to provide larval control. Larval control (larviciding) is very effective in the reduction of mosquitos in their larvae stage as this is the only time in the insects life cycle when it is truly confined, concentrated and most readily controlled. Larviciding will be conducted on pooled waters, catch basins containing stagnet water, and other poor drainage areas at least every other week during the program season. All areas will be monitored weekly, however, to determine if more frequent application of larvicide is necessary.

3701-36-17 CHILD HEALTH

Two administrators of the Franklin County Board of Health serve on the Advisory Committee to the Child and Family Health Services Block Grant for Franklin County. This advisory committee is in the process of assessing: 1) the existing health care system available for children, 2) promoting and coordinating the appropriate utilization of health services, and 3) developing programs to meet needs.

3701-36-18 NUTRITION SERVICES

The Franklin County Board of Health contracts with the Franklin County Cooperative Extension Service to provide nutrition education programs. In addition, public health nurses provide special dietary counseling and assess the outcome of the dietary counseling.

3701-36-20 FAMILY PLANNING

Two administrators of the Franklin County Board of Health serve on the Advisory Committee to the Child and Family Health Services Block Grant for Franklin County. This Advisory Committee has developed a list of reproductive health services available in the community. Representatives of the Ohio State University High Risk Department and the Planned Parenthood Organization are available for consultation and the provision of family planning services. Public health nurses interview potential high-risk women and give information concerning family planning.

3701-36-21 SUBSTANCE ABUSE

Medical care and health counseling is provided at the Franklin County Board of Health for individuals with a history of alcohol abuse. Group education sessions are being planned.

3701-36-22 DISASTER PREPAREDNESS

The Franklin County Board of Health has established a disaster plan in cooperation with the Franklin County Disaster Services Agency. This plan details the responsibilities, in the event of a disaster, for which a public health department would assume. A Disaster Emergency Operations Center is maintained by the Board of Health, located at Mary ~~Street~~, 1755 Alum Creek Drive, Columbus, Ohio.

3701-36-23 ACCIDENT PREVENTION

A surveillance system for accidents is being developed. Analysis of the major causes of accidents in Franklin County will be conducted. A program will be developed after this analysis is completed.
