

AMENDED ORDINANCE NO. 6-87

An Ordinance to amend Rule 1 and Rule 8 of Section 220.01 of the Codified Ordinances of the City of Bexley to require meetings of the Bexley City Council, and the Standing Committees thereof, to be held at City Hall unless a majority of the Council or a Standing Committee determine that a meeting should be held elsewhere.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY,  
STATE OF OHIO:

Section 1. That Rule 1 and Rule 8 of Section 220.02 of the Codified Ordinances of the City of Bexley be amended to read as follows:

Rule 1. Regular Meetings.

- (a) At 7:00 p.m. on the first Monday in January following a regular Municipal election, Council shall meet IN THE COUNCIL CHAMBER at the usual place of holding its meetings, at which time the newly elected members of Council shall assume the duties of their office, and Council shall elect one of its members President, who shall preside at meetings of Council and perform such duties as presiding officer as may be imposed on him by Council. In the absence of the President at any meeting, Council shall elect a President Protempore. Thereafter, Council shall meet in regular meetings at the Council Chamber on the second and fourth Tuesdays of each month at 7:00 p.m. and at such other times as may be ordered by Council, except that Council may designate one month in the summer season for vacation.
- (b) When a meeting is held on the first Monday in January, as provided in subsection (a) hereof, the meeting on the second Tuesday in such month may be omitted.
- (c) ALL MEETINGS OF THE COUNCIL SHALL BE HELD IN THE COUNCIL CHAMBER, UNLESS A MAJORITY OF ALL THE MEMBERS ELECTED DETERMINE THAT A MEETING SHOULD BE HELD ELSEWHERE.

Rule 8. Standing Committees. Standing Committees shall be appointed by the President at the first regular meeting in January in each year, and the first named member of any Committee shall be the Chairman. Such committees shall each consist of three members, shall serve for the period of one year and until their successors are appointed, and shall be as follows:


1. Engineering and Plats;
2. Finance and Judiciary;
3. Parks and Forestry;
4. Safety, the duties of which shall relate to police, fire, health and buildings;
5. Service, the duties of which shall relate to streets, sidewalks, lights and such other matters as are not included within the duties of the other committees herein provided for; and
6. Water, Sewers and Drainage.

THE MEETINGS OF ALL STANDING COMMITTEES SHALL BE HELD AT CITY HALL, UNLESS A MAJORITY OF THE MEMBERS OF SUCH COMMITTEES DETERMINE THAT A MEETING SHOULD BE HELD ELSEWHERE.


Section 2. That existing Rule 1 and Rule 8 of Section 220.01 of the Codified Ordinances of the City of Bexley are hereby repealed.

Section 3. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.


