An Ordinance to appropriate \$39,700 from the unencumbered General Fund, to transfer \$27,700 from the unencumbered General Fund to the Recreation Fund and to appropriate said amount from the Recreation Fund, to appropriate \$2,583.56 from the Water Fund, to transfer \$3,000 from the unencumbered General Fund to the Street Fund and to appropriate said amount from the Street Fund and to appropriate \$10,000 from the Sewer Fund.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY,
OHIO:

Section 1: That \$39,700 is hereby appropriated and set aside from the unencumbered General Fund for the following purposes:

Section 5: That \$10,000 is hereby appropriated and set aside from the Sewer Fund for the purpose of paying salaries and wages from Account No. 10-360-101.
