

ORDINANCE NO. 77 - 90By: Mark R. Masser

An Ordinance to approve a contract with the City of Columbus, Division of Police, for the services of the Columbus Police Crime Lab and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and Auditor be, and they hereby are, authorized to execute a contract with the City of Columbus for services of the Columbus Police Crime Lab, which contract effects a change in fees charged for certain services of the lab effective November 1, 1990.

Section 2. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety, said emergency being the need to have available to the City the uninterrupted services of the Columbus Police Crime Lab, and shall take effect and be in force immediately upon its passage and approval by the Mayor.

CONTRACT FOR SERVICES OF COLUMBUS POLICE CRIME LAB

This Contract with an effective date of November 1, 1990, is made and entered into at Columbus, Ohio, Pursuant to Ordinance No. 1153-82, adopted by the City Council of the City of Columbus, Ohio at its June 21, 1982 meeting, by the City of Columbus, acting through the Division of Police, Department of Public Safety, hereinafter referred to as the "City,"

and

acting through its Police Department, hereinafter referred to as the "User," for the purpose of providing the services of the Columbus Police Crime Lab.

IT IS HEREBY AGREED among and between the said City and the User that the said City shall provide the services of the Columbus Crime Lab as set forth below. Moreover, the said User agrees to pay the City the said amounts designated below for the specified services. The City shall invoice the User for the services performed. The User shall make payment to the City of Columbus, in care of the Business Office, Columbus Division of Police, 120 West Gay Street, Columbus, Ohio 43215, within thirty (30) days upon receipt of the said invoice
