

ORDINANCE NO. 15-05BY: Helen MacMurray

An Ordinance to authorize contracts for building construction inspection services as required by the Ohio Building Code, Chapter 4101:2-1-45.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and Auditor be, and each of them hereby is, authorized and directed to execute an agreement with Benatec Associates, to provide backup services for the positions of backup chief building official, plans examiner, and inspector for the Building Department, a copy of which is attached.

Section 2. That the Mayor and Auditor be, and each of them hereby is, authorized and directed to execute an agreement with Benatec Associates, to provide backup plans examination services and backup chief building services for the Building Department, a copy of which is attached.

Section 3. That this Ordinance shall go into effect and be in force from and after the earliest period allowed by law.

BETWEEN THE CITY OF BEXLEY, OHIO, AND BENATEC ASSOCIATES.

WITNESSETH


Section 1. Benatec Associates, shall, for consideration hereinafter stated, furnish to the City of Bexley, Ohio, and the inhabitants thereof, backup Chief Building Official, Plans Examiner and inspection services as requested by the City.

Section 2. Said services shall be furnished for a period beginning January 1, 2005 and remaining in force until December 31, 2005 provided, however, that either party to this agreement shall have the right to cancel the same upon three (3) months written notice.

Section 3. The City of Bexley, Ohio shall pay Benatec Associates for said services furnished to the City of Bexley, Ohio, and the inhabitants thereof, \$64.00 per hour. The City of Bexley, Ohio to issue all permits and collect all fees.

Section 4. Said sum of sums of money shall be paid by the City of Bexley, Ohio, to Benatec Associates monthly and shall be paid with thirty (30) days after receipt of a statement.

IN WITNESS WHEREOF, the parties to this agreement have hereunto set their hands and have executed this agreement this 8th day of March, 2005.


