

Amended ORDINANCE No. 16 - 09By: Ben Kessler

An Ordinance to amend the Campus Planning District in accordance with Amended Ordinance No. 88-03, and rezone the parcels listed below, properties owned by Capital University to the Campus Planning (CP) district, Zone 1:

Whereas, all properties are within the area depicted in the Southwest Bexley Master Plan as the 'Capital University Campus'; and

Whereas, all of the properties, except the Astor Avenue property, are within the 'Future Phase' of the CP district as depicted on Exhibit A of Amended Ordinance No. 88-03, the Ordinance that rezoned a major portion of the Campus Planning District to the CP zoning classification; and

Whereas, the rezoning request is consistent with the recommendations of the Southwest Bexley Master Plan and the Memorandum of Understanding (the "MOU") between Capital University, Trinity Lutheran Seminary and the City of Bexley, Ohio entered into in March of 2004; now THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That this Ordinance shall further amend the Campus Planning District in accordance with Amended Ordinance No. 88-03, and will rezone the parcels listed above, properties owned by Capital University, from R-12 and Planned Unit Residential (PUR) to the Campus Planning (CP) district, Zone 1.

Section 2. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
