#### NARRATIVE FOR PATROL OFFICER EDWARD P GLICK

#### Ref: 20BEX-3321-OF

On 3/11/20 at 0213 hours a traffic stop was conducted on OH \*\*\*\*\*\* A short, dark haired female white had exited the vehicle prior to the stop and been contacted by BPD. During the traffic stop drug paraphernalia was observed in plain view. A subsequent probable cause search located additional paraphernalia, drug abuse instruments and illegal drugs. The operator, under Miranda warnings, positively identified the female suspect who had left. Items in the vehicle had her information and the contacting officer also positively identified her from her BMV photo. A warrant for drug abuse instruments was issued and a future for possession of drugs will be forthcoming after lab results.
