On 4/16/22 at 0004 hours a traffic stop was conducted in the 2000 block of Clifton Ave. All three of the rear passengers made furtive movements prior to officer contact. The four occupants were removed from the vehicle. A package of THC edibles was revealed on the rear floor where Suspect #2 was seated. A probable cause search located additional THC edibles between the driver seat and center console, where Suspect #1 had been seated. Suspect #1 and Suspect #2 will be issued summonses for possession of hashish.
